Language

Use good, explicit English. Consult a native speaker and/or dictionary where necessary.

Manuscript Preparation

The manuscript should be double spaced with wide margins. In general, each manuscript needs to contain (in the following order) a Title, author, affiliations (and addresses), abstract, keywords, PACS, AMS classifications, and the numbering should be consecutive. Full details are available online at www.ejmaps.org/guide.htm. A template is available at www.ejmaps.org/template.htm, however authors are encouraged to consult the most recently published articles (for either MS WORD files or TEX files) for more detailed guidelines.

Communication

The full postal address, fax, and telephone numbers, as well as e-mail addresses of the corresponding author(s) must be provided on the first (title) page of the manuscript.

Electronic scripts

In case the file size exceeds a reasonable amount, authors are encouraged to send an electronic file on disk to the editor handling the manuscript. If the author submits the paper via airmail, than the electronic file will only be requested after the acceptance of the paper.

Color

Since publication will commence electronically, there are no additional charges for color reproduction.

Referees

Every paper is subject to peer review. The author can suggest a list of three-five potential referees in the review process. All details of phone, address, fax, etc must be provided, however, the editors will not necessarily approach them.
